Dear Chairman Durbin and Ranking Member Grassley:

As legal adversaries who have prosecuted clients of Lara Montecalvo, we write to offer our unreserved endorsement of her nomination as Circuit Judge for the United States Court of Appeals for the First Circuit.

Between 2004 to the present, Ms. Montecalvo has represented indigent criminal defendants in cases involving a wide diversity of factual and legal matters.
