3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Overdose Review Team5 Act".

1SEC. 2. FUNDING TO ESTABLISH DRUG OVERDOSE FATAL-2ITY REVIEW TEAMS.

3 Part A of title XI of the Social Security Act (42
4 U.S.C. 1301 et seq.) is amended by adding at the end
5 the following:

6 "SEC. 1150D. GRANTS TO ESTABLISH DRUG OVERDOSE FA7 TALITY REVIEW TEAMS.

8 "(a) GRANTS.—The Secretary shall, using amounts 9 appropriated under this section, award grants to States, 10 units of local government, and Indian Tribes to establish, 11 expand, or maintain a Drug Overdose Fatality Review 12 Team, which shall—

13 "(1) promote cooperation and coordination
14 among agencies involved in the investigation of fatal
15 and non-fatal drug overdoses;

16 "(2) develop an understanding of the causes
17 and incidences of drug overdoses in the jurisdiction
18 where the team operates;

"(3) track the total number of drug overdose
deaths and identify trends and patterns in fatal and
non-fatal drug overdoses in the jurisdiction where
the team operates;

23 "(4) plan for and recommend changes within
24 the agencies to prevent drug overdose fatalities;

25 "(5) recommend best practices for preventing
26 drug overdoses and drug overdose deaths; and

1	"(6) advise policymakers in the team's jurisdic-
2	tion about potential changes to law, policy, funding,
3	or practices to prevent drug overdoses.
4	"(b) GRANT RECIPIENTS.—The Secretary shall not
5	award grant funds under this section to a recipient unless
6	the recipient provides to the Secretary a list of individuals
7	on the drug overdose fatality review team, which shall in-
8	clude—
9	((1) not less than 1 representative each from—
10	"(A) the State, local, or Tribal department
11	of health, or similar department;
12	"(B) the State, local, or Tribal govern-
13	mental entity responsible for alcohol, drug, or
14	other substance addiction treatment and serv-
15	ices;
16	"(C) the State, local, or Tribal department
17	of social services, or similar department;
18	"(D) the State, local or Tribal attorney's
19	office;
20	"(E) law enforcement agencies of the juris-
21	diction, which may include representatives of
22	law enforcement agencies operating in a high
23	intensity drug trafficking area designated pur-
24	suant to section 707(b) of the Office of Na-

1	tional Drug Control Policy Reauthorization Act
2	of 1998 (21 U.S.C. 1706(b));
3	"(F) the State, local, or Tribal department
4	of corrections, or similar department; and
5	"(G) the State, local or Tribal medical ex-
6	aminer or coroner;
7	"(2) a health care provider who specializes in
8	the diagnosis and treatment of substance use and
9	misuse and substance use disorders;
10	"(3) a health care provider who specializes in
11	treating co-occurring mental health and substance
12	use disorders;
13	"(4) a representative from emergency medical
14	services;
15	"(5) a patient advocate who has lived experi-
16	ence with substance use and misuse or who has a
17	family member with a history of substance use and
18	misuse;
19	"(6) an emergency department physician;
20	"(7) a toxicologist; and
21	"(8) a community-based substance use preven-
22	tion coalition leader or other community-based sub-
23	stance use prevention professional.
24	"(c) APPROPRIATION.—In addition to amounts other-
25	wise available, there is appropriated to the Secretary for

fiscal year 2023, out of any money in the Treasury not
 otherwise appropriated, \$50,000,000, to remain available
 until 2027, to carry out this section.

4 "(d) DEFINITIONS.—In this section:

5 "(1) INDIAN TRIBE.—The term 'Indian Tribe'
6 has the meaning given that term in section 4(e) of
7 the Indian Self-Determination and Education Assist8 ance Act (25 U.S.C. 5304(e)).

9 "(2) STATE.—The term 'State' has the mean-10 ing given that term in section 1101(a)(1) for pur-11 poses of this title and includes the Commonwealth of 12 the Northern Mariana Islands, and American 13 Samoa.".
