Dear Judge Mauskopf:

We write to request that the Judicial Conference exercise its authority pursuant to 5 U.S.C. § 13106(b) to refer Associate Justice of the Supreme Court Clarence Thomas to the U.S. Attorney General. There is reasonable cause to believe that Justice Thomas willfully failed to file information required to be reported under the Ethics in Government Act of 1978.

On April 13, 2023, ProPublica reported that Justice Thomas failed to disclose the sale of his interest in three properties in Savannah, Georgia, to the billionaire Harlan Crow in 2014. <sup>1</sup> Justice Thomas reported his interest in those properties when he was an official in the George H.W. Bush administration, and continued to report his interest during his tenure on the Supreme Court. <sup>2</sup> However, when Crow bought those properties in 2014—potentially paying well over market value <sup>3</sup>—Justice Thomas failed to report the sale, in an apparent direct violation of 5 U.S.C. § 13104(a)(5).

The requirements of 5 U.S.C. § 13104(a)(5) are plain and unambiguous. That provision states that a reporting official must provide "a brief description, the date, and category of value of any purchase, sale or exchange during the preceding calendar year which exceeds \$1,000" in real property, "other than property used solely as a personal residence of the reporting individual or the individual's spouse." The transaction value exceeded \$1,000, and the exception was clearly inapplicable.

Justice Thomas's failure to report this transaction is part of an apparent pattern of noncompliance with disclosure requirements. Last week, ProPublica reported that Justice Thomas accepted luxury trips from Crow virtually every year for more than two decades, including private jet flights, international cruises on a superyacht, and regular stays at Crow's private resorts, without disclosing almost any of them.<sup>5</sup> The details of those potential disclosure violations are well documented in Campaign Legal Center's April 11, 2023, letter requesting that the Judicial Conference refer Justice Thomas to the Attorney General for failure to report those gifts.<sup>6</sup>

In 2011, Justice Thomas admitted omitting his spouse's income on his disclosure statements after watchdog groups revealed that he failed to report his wife's income for several years. Justice Thomas stated it was "a misunderstanding of the filing instructions," despite accurately filing disclosure forms regarding his spouse's employment for as many as 10 years beginning in 1987.

Given this history, there is at least reasonable cause to believe that Justice Thomas intentionally disregarded the disclosure requirement to report the sale of his interest in the Savannah properties in an attempt to hide the extent of his financial relationship with Crow. The Judicial Conference is the authorized "supervising ethics office" for judicial officers, including Supreme Court Justices. Pursuant to 5 U.S.C. § 13106(b), the Judicial Conference "shall refer to the Attorney General the name of any individual which such official or committee has reasonable cause to believe has willfully failed to file a report or has willfully falsified or willfully failed to file information required to be reported."

We thus request that the Judicial Conference refer Justice Thomas to the Attorney General for further action. Potential violations of disclosure laws by officers of the highest court merit serious investigation, and it is well past time for the Supreme Court to align with the rest of the government on ethics requirements.
